 - Eliminate barriers to XBRL data use
 - Expand XBRL use across the US economy
 - Establish sustainable business model for the standard

CSC Mission

	How to Join	Rights	Attendance Requirements
Observer	Make request of XBRL US administration	Can receive (but not post) to committee email list; can attend meetings but can participate only on approval of the Chair	None
Non-voting member	Make request of XBRL US administration and can participate but not vote	Can post to committee email list; can attend and participate but not vote	None
Voting member	Same as Non-voting member	All rights of voting member; can also vote	Loses Voting Member status if absent 3+ consecutive meetings or 6 consecutive weeks, whichever is longer. Can be reinstated by attending two consecutive meetings.
